

NOTICE TO PUBLIC Community Development Block Grant Program

The City of Easton is seeking comments on a proposed budget modification to the FY 2014 CDBG Program. The City received FY 2014 program income from the sale of properties in the amount of \$83,112.40. The City proposes to use these funds for projected activities of Acquisition and Rehabilitation for FY 2015. The program income increases the allocation for this activity by more than 25%. Copies of the Modification to the Action Plan for F.Y. 2014 are available for public inspection and review at the following locations for a thirty-day period from March 18, 2015 at the City Clerk's Office, Easton Government Center, 6th Floor, One South Third Street, Easton, PA 18042. The City of Easton will hold a public hearing on Wednesday, March 25, 2015, 6:00 p.m. to solicit citizen comments on the FY 2014 proposed budget modification. The hearing will be held at 6:00 p.m in the Council Chambers, City Hall, 1 S. Third St. Easton, PA. The City of Easton has also received notice of the 2015 allocation from the U.S. Department of Housing and Urban Development for the CDBG program year which runs January 1, 2015 through December 31, 2015. The sum is \$35,068 more than anticipated for a total of \$785,068. The City will allocate the additional funds for acquisition and rehabilitation and administration. Copies of the revised action plan for F.Y. 2015 are available for public inspection and review at the following locations for a 30 day period from March 18, 2015: City Clerk's Office, Easton Government Center, 6th floor, One S. 3rd Street, Northampton County Government Center, 669 Washington Street, Easton Public Library, Church and 6th Streets, and the Easton Area Neighborhood Center, 902 Philadelphia Rd.
